What Is Institutional Accreditation?






- [A]n expression of confidence in an institution's mission and goals, its performance, and its resources.
- An institution is accredited when the educational community has verified that the institution's mission and goals are achieved.
- Key components
 - self-regulation (our ongoing efforts)
 - peer review (Accreditation team).



8-YEAR ACCREDITATION CYCLE





Accreditation





- Designed to show that each University has a rigorous and effective program of instruction that fulfills its mission.
 - Seven Standards and Fundamental Elements
 - Specific focus on assessments and planning
- NDU's accreditation body is the Middle States Commission on Higher Education (MSCHE)
 - Generally Responsible for 5 States, Puerto Rico, US Virgin Islands and the District of Columbia
 - All degree-granting institutions, private, state, civilian, and military



Purpose and Process of Self Study



The Self-study process requires that institutions engage in an in-depth, comprehensive, inclusive, and reflective assessment process to identify and address institutional priorities as well as opportunities for improvement and innovation.

Through this process, the institution must provide evidence and document compliance with the Commission's standards for accreditation, requirements of affiliation, policies and procedures, and federal compliance requirements.



Intended Outcomes of the Self-Study



- 1. Demonstrate that NDU meets the Standards for Accreditation and Requirements for Affiliation.
- 2. An improved institution.
- 3. An inclusive and transparent self-appraisal process.
- 4. Inspire a culture of collaboration, innovation, and fiscal responsibility.
- 5. Produce a new strategic plan with metrics and an evaluation plan.




