### **NDU Transformation**





### SecDef Esper in Defense Wide Review (DWR) tasked NDU to propose a plan to eliminate CIC and CISA

The recommendation from NDU and the Joint Staff (JS) proposed to integrate CISA and CIC Joint
Professional Military Education – Phase II (JPME II) programs into the NWC and ES degree programs,
and offer elective concentrations in Counterterrorism/Irregular Warfare (CTIW) and Cyber/Info (CI)

### SecDef also tasked NDU to focus on its core mission of JPME

The NDU/JS recommendation proposed to divest non-core programs

### **Congress does not support NDU Transformation initiatives**

We have ceased all planning for implementation; focus is entirely upon delivery of this year's program

# Fiscal Year 2021 (FY21) National Defense Authorization Act (NDAA) Conference Report directs the next steps (next slide)

#### SecDef also tasked:

- Focus 50% of curriculum on strategic competitors, with focus on China
- Address emerging and disruptive technologies
- Increase international students by 50% over the next five years.

## **FY 2021 NDAA Conference Report**





Prohibits the Secretary from any action to eliminate, divest, downsize, reorganize, or seek to reduce the number of students at CIC and CISA pending completion of reports

### **Directs the Secretary to:**

- Report by 01 FEB 21 an assessment of the requirements for JPME and civilian leader education in counterterrorism, irregular warfare, and asymmetrical domains and relevant recommendations
- Brief the defense committees by 01 MAR 21 and report by 01 May 21 an assessment of the requirements for JPME and civilian leader education in the information environment and cyberspace domain and relevant recommendations
- Prohibits obligating or expending more than 60 percent of the funds authorized to be appropriated for NDU until 60 days after the date on which the congressional defense committees receive the report

## **Budget Status on Transformation Action**





Responding to DWR tasks, NDU Transformation recommendations projected potential savings of \$6.9M – primarily through divesting some non-JPME programs

An additional Office of the SecDef (OSD)-directed \$0.9M civilian pay reduction and topline reduction for POM-22 (\$2.5M, 13 FTEs per year) resulted in the Joint Staff reducing the NDU budget authority by \$10.3M per year and 51 Full-Time Equivalent (FTE) positions

- Reduction is approximately 10% of the NDU top line
- Joint Staff budget also reduced 10%

#### In October 2020:

- OSD restored the \$2.5M and 13 FTEs in FY 2022, leaving NDU with \$7.8M and 38 FTEs to source
- Budget discussion / reclama with Joint Staff
  - Direction to operate within this reduced top line
  - Guidance about where to take risk (next slide)

# **Guiding Principles**





### To balance mission requirements with available resources:

### Maintain academic rigor required by statute and accreditation required by SecDef

 Accreditation assesses our programs as we define their elements; what elements of our current programs are not "required"?

### Maintain student throughput

OK to reduce student throughput

### Preserve Civilian Pay (CIVPAY) and FTEs where possible

Accept additional risk in non-pay

# Protect IT Sustainment/Restoration/Modernization (SRM) - Found insufficient in the past two accreditation visits


- Accept risk in the velocity of the IT Modernization
- Preserve Student Information System

# **FY 2022 Budget Submission**





### To balance mission requirements with available resources:

IT Program	\$ 3,300 K
Student International Travel	\$ 2,100 K
NDU and Component Operations	\$ 1,200 K
Anticipated Savings	\$ 1,200 K
Total	\$ 7,800 K

OSD Comptroller is now planning to draft a Program Budget Decision (PBD) for restoral consideration of DWR/transformation action. This PBD will have to be approved by the Secretary of Defense during the FY 2022 President's Budget decision cycle.
